### 1. Buyer Added Bid Specific ATC

1) Eligible makes for Participation are **Exide/ Amaron Quanta** rest makes shall not be considered for technical evaluation.

2) **Rates are to be quoted inclusive of Buy Back i.e For Example if Rate of New Battery is X and Rate of Buy Back Battery of same capacity is Y, then the Quoted Rate shall be (X-Y)**

3) For **Technical evaluation** bidders are requested to submit the following documents.

a) **Copies of work order/experience certificate executed in FY 2021-22 & 2022-23 in support of condition specified in Bid document for years of past experience i.e. 2 years** which states as " the bidder or its OEM (themselves or through reseller(s) should have regularly, manufactured and supplied same or similar Category Products to any central / state Govt organization/PSU/ Public Listed Company for number of financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year.

b) **Copies of work order/experience certificate executed in FY 2021-22 & 2022-23 in support of condition of past experience** which states that" the bidder or its OEM (themselves or through reseller(s)) should have supplied same or similar Category Products for 80% (22 batteries) of bid quantity ( 28 batteries) in at least one of the last two financial years before the bid opening date to any central / state Govt organization/PSU/ Public Listed Company . Copies of relevant contracts ( proving supply of cumulative order quantity in any one financial year ) to be submitted along with bid in support of quantity supplied in the relevant financial year."

4) **Unloading charges** are to be paid by the successful bidder. Also the successful vendor ensure the Supply / Installation / Testing / Commission of batteries at the respective locations at his own cost.

### 2. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
