Contractors are requested to note that non-compliance of the following instructions is liable to render their tender non-bonafide.

- 1) Sealed tenders are invited on item rate basis. You are requested to quote your lowest rate for SITC items & highest rate for buyback items. Your quoted rate will be inclusive of all taxes/duties/levies/labour welfare cess etc which are not subsumed in GST but excluding GST as applicable which will be paid extra at the prevailing at the time of billing. While quoting your rate necessary cost towards transportation/loading & unloading shall be considered. It is also advised to quote the rate after considering the input tax credit advantage and adjusting/deducting the same in the quoted rate/amount. GST on works contract will be paid extra along with bill payment as per applicable rate of GST at the time of billing. No extra payment shall be made towards transportation, loading & unloading, fooding & staying etc.
- 2) Tenderers shall quote their rates both in figures and words.
- 3) Contractors should put their firm's endorsement on each page of the tender document as token of perusal.
- 4) Tender shall be submitted within specified time. Delay in any reason shall not be considered including postal delay also.

NAME OF THE WORK: TENDER FOR ANNUAL RATE CONTRACT FOR SUPPLY AND INSTALLATION OF 12V-42AH/26AH/28AH/65AH SMF BATTERIES AT VARIOUS OFFICES UNDER SILCHAR DO.

- 1) For smooth maintenance aspect, or delay in execution of work by lowest vendor, LICI may divide/split the work and award other than L-1 on lowest accepted tender rate also. LICI reserves the right to award any job in favour of any contractor or split the job on lowest rate or cancel the tender without showing any reason.LIC of India reserves the right to award the lowest tender rate to one or more willing successful or selected electrical contractors.
- 2) Contract period is valid for two years from the date of issuing acceptance letter. However the contract may be extended further with existing rate and terms & conditions, if the performance of the vendor is satisfactory, mutual consent of LICI & contractor and approval of the competent authority. The rates quoted for all items shall be firm throughout the period of contract including extension granted if any. No escalation of the price of materials shall be given consideration. Above contract or a part of the contract may be terminated by the competent authority serving 30 days notice to the vendor, if the services of the vendor is not satisfactory.
- 3) Quantity of order for supply of SMF battery may vary upto any extent. Order for supply shall be placed based on requirement of concerned offices for any quantity of battery. LICI has the right to decide the quantity of battery to be supplied /replaced. It is not necessary that entire battery bank of UPS will be changed.
- 4) Completion time for supply of battery against individual order is Ten days from the date of individual order.
- 5) Delay in completion of work within the stipulated time without any valid reasons shall make the contractor liable for liquidated damages @1% of accepted tender amount (ie individual order value) per week for delay beyond completion time subject to maximum of @10%.
- 6) Contractor shall be responsible to carry out rectification of defects, if any, pointed out to him during the defect liability period, failing which LICI may get the job done through any other agency at the risk & cost of contractor to whom work has been awarded originally.
- 7) For genuineness of the battery contractor may be asked for submission of Guarantee Card/Certification of OEM.
- 8) No Battery shall be used other than the make provided in the tender without approval of the Competent Authority.
- 9) Guarantee/Warranty of the Battery will be minimum Two Years (ie Twenty four months) from the date of successful completion of SITC work at site. If the OEM provides Guarantee/Warranty period more than 24 months for their product then it will carry highest Guarantee/Warranty period for this contract.
- **10)** Materials to be used as per approved list of materials.
- 11) Quantities are variable and to be finalized during placing work order. However contractor has to supply any quantity of Battery ranging from one upto capacity of battery bank. Payment will be made as per actual quantities.
