- 2. Similar nature of Works means works of Office, Residential Buildings, Shopping Complex, Commercial Building, Institutional Building but not Industrial buildings like Ware house, Factories, plants, etc unless otherwise mentioned specifically.

Applicants/ Bidders should have completed 5 in numbers of any of following Key Construction Activities as included in the scope of the proposed work, either completed separately or combined in qualifying works (contract completed):

- ii. Air conditioning.
- iii. Network and Telephone cabling, Fire alarm & Fire Fighting work.
- iv. Modernization works (like office interior works, Modular Furniture, storage units & supply of chairs)
- v. Vitrified tile / Granite flooring
