Copies of relevant con tracts to be submitted along with bid in support of having supplied some quantity during each of the financial year."

c) Declaration on the letter head of the vendor that

He agrees that quoted rates are valid for a period of one year and agrees to supply any quant ity of the printer heads at any time within 1 (one) year from the placement of contract over a nd above the ordered quantity of 50 Printer Heads.

2) Quoted Rates are valid for a period of 1 (One) year.
