Order for new fire extinguishers shall satisfy the conditions viz: Latest IS code, ISI Certificate of approval, Certificate from Deptt. of Explosives, Gas filling Certificates, Certificate of Hydraulic pressure testing, appropriate ISO/ISI mark on the extinguishers.

Interested Bidders should submit their application in Sealed Envelope

Supporting documents as mentioned under technical conditions specified here below, and also the EMD of Rs.10,000/- (rupees ten thousand only) should also be enclosed along with application form. This Envelope should be sealed and super-scribed as **“Tender for Supply and installation of New Fire Extinguishers”**.

- Envelope No. 1 :
 - Tender Application fee of Rs. 118 /- (including GST) by DD in favour of LIC of India payable at Mysore (in case Tender Fees not deposited in cash at DO, Mysore).
 - EMD of Rs. 10000/- by DD in favour of LIC of India payable at Mysore.

- Envelope No. 2 (in sealed quotation) – Financial Bid – your quoted rate of specified items.
- Envelope No. 3 - Both the Envelopes no. 1 & 2

and should reach us on or before 14.10.2024 at 4.15 Hrs. The tenders will be opened on 15.10.2024 at 11.30 hrs. Only one representative of the bidder can remain present for the tender opening.

- 1) It may be noted that the submission of the offer itself shall not be construed as acceptance of all the terms and conditions mentioned here.
- 2) The Tenderer is required to submit refundable 'Earnest Money Deposit' of Rs 10,000/- (Rupees ten thousand only) in the form of Demand Draft from any Scheduled Bank, drawn in favour of Life Insurance Corporation of India, payable at Mysore.
- 3) EMD will be refunded without interest. In addition to that LIC of India may decide to debar/blacklist the concerned supplier and the decision will be final and binding on all concerned.
- 4) Once the tender is submitted, no tenderer will be allowed to withdraw the tender, for whatsoever may be the reason. If, any tenderer withdraws the tender, the tenderer will forfeit the EMD.
- 5) All the pages of the tender form are to be signed by the bidder. Incomplete bids are liable to be rejected.
- 6) Relevant documents/certificates as called for, in the technical condition should be enclosed along with the tender. The Corporation reserves the right to call for any further documents/information, if needed, from any/all the bidders.
- 7) Please study the documents carefully and inspect the site before filling-in the tender. Any party tendering against the enquiry shall be deemed to have read and understood all the terms and conditions and familiarized themselves with the site and nature of work and quoted accordingly. Such terms and conditions not appearing in the body of the tender will not be considered as forming a part of their tender.
- 8) The Corporation reserves the right to accept/reject any or all tenders at its sole discretion, without assigning reasons there-for. The Corporation also reserves the right to call for missing/additional documents, if required, from the responding bidders.

9) Payment Terms :

- (i) No advance payment will be made.
- (ii) Full and Final payments shall be made only after successful installation of Fire Extinguishers as mentioned and confirmation thereof from Manager(E&OS), LIC of India, Divisional Office, Mysore.

10)Penalty- In case of unsatisfactory performance, penalty at the following rate will be levied:-

- (a) In case of delay in delivery and installation of Fire Extinguisher, penalty of Rs.50/- (rupees fifty only), per fire extinguisher, for each day of delay will be levied.
- (b) In case of non-functioning of any fire extinguisher, replacement of such defective fire extinguisher should be done within 5 days from the date of intimation, failing which penalty of Rs. 20/- (Rupees twenty Only), per fire extinguisher, per day , will be levied.
- (c) In addition to the above penalty, in case of non-satisfactory service and refilling of Fire Extinguishers, the Corporation also reserves the right to blacklist the empanelled bidder, for unsatisfactory performance.

Any dispute arising out of or relating to this tender shall be deemed to have arisen at the headquarters of the Corporation's Divisional Office in Mysore placing the order and shall be subject to adjudication by the Court in Mysore city.
