In the presence of bidders. All are requested to be present on that day.

GENERAL & TECHNICAL CONDITIONS:-

- 1) Quotation for Fire extinguishers should include 5 year warranty inclusive of coverage for manufacturing mechanical defect as well as the cost of refilling and recharging in case pressure falls below acceptance level.
- 2) Periodical Inspection – The vendor should arrange for half yearly inspection of Fire Extinguishers, during the period of warranty without any cost. The inspection will be jointly conducted by a representative of the bidder and a representative of the Corporation and record is to be maintained.

The refund of EMD is subject to satisfactory compliance to this condition.

- 3) The tenderer will impart training to all staff members through live demonstration without any extra cost during warranty period. The Schedule of training may be fixed in consultation with the Manager (E&OS).
- 4) The tenderer has to put sticker on each extinguisher mentioning thereon the date of installation, date of expiry etc.
- 5) Inspection of the Extinguishers should be undertaken in a phased manner. Further, in case the Extinguishers are taken back for refilling for any reason whatsoever, during the warranty period, substitute arrangement should be made by the vendor, till the original Extinguishers are replaced.
- 6) A copy of the ISI certificate issued by Bureau of Indian Standard should be submitted long with the quotation. The Certificate should clearly mention the respective type of Extinguishers and the validity period.
- 7) Delivery and installation should be within 15 days after placing the Order.
- 8) After installation of Fire Extinguishers, if any Fire Extinguisher is found defective, such defective fire extinguishers should be replaced within 5 days from the date of intimation.
- 9) On-site sample checking of the Fire Extinguishers will be done at the time of installation, by us.
