3. Comprehensive Annual Maintenance Contract (CAMC) shall cover all the items required for maintenance of the fire detection, fire alarm system, fire hydrant system & Sprinkler systems.

4. Under the CAMC contract **Monthly visits are to be made** at the above mentioned locations and payment of bills shall be done on Quarterly Basis on the submission of Bill along with monthly / Quarterly /half yearly check reports duly verified by the concerned LIC official of the respective Office.

Schedule of Checkups to be performed are as under:

- A.C Supply of battery charging indicators
- Checking of battery charging indicators
- Checking of individual zone fire indicators

5. Before commencement of CAMC contract of the entire fire detection, fire alarm system, fire hydrant system & Sprinkler system will be handed over to the agency in working condition. In case system is not functioning due to defective parts then the agency has to submit the report to LIC and after joint verification the agency has to carry out the necessary repairs. The cost of the parts will be reimbursed to the agency as per actual purchase plus 15% contractor's profit. Once the Installation is made functioning properly for the first time then nothing extra will be paid for the replacement of any parts major or minor and agency has to replace the same with the approved make of Brands at their own cost.

6. During the period of CAMC successful bidder shall attend to all repairs / defects / replacement of major / minor spare parts without any extra cost.

7. Apart from the mandatory visits, if any problem arises in fire detection, fire alarm system, fire hydrant system & Sprinkler system shall be rectified as per schedule mentioned hereunder:

8. The time which will be treated as the time of lodgment of the complaint will be the 1st call on mobile or the time of 1st email sent to the official email id of the vendor in this regard. In case of failure in providing service within the above time frame, corporation reserves the right to impose penalty as mentioned hereunder:

9. The Penalty amount will be recovered from the CAMC payment lying with the office. Complaint (s) will be deemed to be resolved only on the availability of the customer call report signed by both the service engineer and Corporation's authorized official, conforming that the complaint is resolved. Date and Time of the resolution of the complaint shall be indicated clearly.

10. Penalty of 1% per week subject to a maximum of 25% contract value per year shall be levied, in case the CAMC is not attended within time, then the same shall be got attended at Risk & Cost of successful vendor.

11. Corporation reserves the right to increase or decrease the servicing locations/items at any time during the currency of the contract. Successful Bidder is bound to accept the orders accordingly.

12. Corporation reserves the right to terminate / cancel the whole or part of the agreement at their sole discretion after giving one month's notice to the service provider. If the contract is terminated by the service provider, it would be liable for penalty which shall be forfeiture of security deposit.

13. Contractor is to fully indemnify the LIC of India against any type of loss/accident caused due to negligence of the contractor and he should take all the precaution for smooth execution of work. The necessary Insurance cover for Third Party Liability and workmen compensation shall be taken in the joint name of LIC & Vendor, which shall remain in force during entire contract period.

14. The electrical work shall be carried out as per IE Rule, Local electricity rules, LIC material specification, General Conditions of the contract and to entire satisfaction of LIC Engineers.

15. Contract shall be valid for a period of Three years at initial instance, it may be extended further for one year on mutually agreed rates and terms and conditions.

16. The Contractor shall ensure maintenance of installation as per the rules and regulations of the Chief Fire Officer, Amritsar. The Contractor shall also abide by the requirements of the office and shall strictly follow the instructions issued from time to time.

17. Rates shall include

Deploying trained worker and carrying out servicing as details in the contract.

To provide all tools & plants required for carrying out maintenance /servicing as detailed in the contract

Cost of replacement of equipments' like detectors, fire panels, hooters, controllers etc required to keep the fire detection system operational.

18. In terms of provisions of Section 33 (3) of the Insurance Act, 1938 as amended by the Insurance Laws (Amendments) ordinance, 2014. Insurance Regulatory Authority of India (IRDAI) is authorized to verify all such books of account, register, other documents and data base in the custody of the contractor in respect of service outsourced by the LIC of India. It shall be the duty of the contractor to provide such documents / statements / information / as may be required by IRDAI within such time as may be specified by the IRDAI.

2. **Generic**
