- 1. The applicant must submit the *Chartered Accountant certified proof of Turnover for the FY* 2021-22, 2022-23 & 2023-24 in support of Average Minimum Annual turnover required for empanelment as indicated against each category.
- 2. The applicant Suppliers/Manufacturers/Printers/Service Providers/Vendors should be in the same profession for at least 3 years as such is required to submit the *copy of work orders / experience certificate executed in each FY 2021-22, 2022-23 & 2023-24* for the works against the category in which applied.
- 3. The applicant must submit the certified *copy of Pan card & GST certificate*
- 4. The applicant must be registered with State / UT / Local authorities; *certified copy certificate of registration* is required to be submitted along with application.
- 5. Vendors participating in the category No. 2 i.e., Supply/installation/testing/commissioning of SMF batteries of Exide/Amaron Quanta are required to furnish valid OEM Authorization certificate of Exide or Amaron Quanta.
- 6. Vendors participating in the category No. 3 i.e., I.T. consumables such as Toners, Ink cartridges, printer heads, CDs etc. are required to submit *authorization letter from original equipment manufacturer (OEM)*.
- 7. Participating vendors having registration / offices outside the Amritsar are required to be on panel of any of the Divisional office / Zonal office / Central Office of LIC of India, or any Central / State Government Organization or PSU, else they shall not be considered for empanelment.
