1. Buyer Added Bid Specific ATC

Kindly Note:

1) This bid is floated for procurement of NACH Mandate Booklets, each booklet having 25 pages with size of each page as 23 cms x 10 cms with **Printing area as 20.32 cms x 9.30 cms** and remaining area shall

be as perforation from the left side. GSM of Paper shall be of 70 GSM with Front Side Multi Color Printing and Covering of the Booklet is of 300 GSM with multicolor printing on both side and back side printing with single color.

2) Quoted rates shall be valid for a period of 1 year, with a provision of 25 % increase or decrease in the tendered quantity.

3) Printing material shall be provided to the successful bidder. Specimen is uploaded in Sample Image of Desired Product details at Page No.2 of the bid document for reference.

4) After award of contract, successful bidder shall submit the soft copy for Proof reading within 7 Days after the art work provided to the bidder and delivery period of one month shall start once proof is approved by the office.

5) Successful bidder is required to make entire supply ordered by LIC of India Srinagar Division within stipulated time of one month or as mentioned in the order and in case the firm fails to supply the goods/items within the time limit/or not as per the required specifications penalty @ as given below will be calculated and deducted from the invoice without any intimation.

8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
